Ruling elder Karen Larson, pastor of the O'Neill church, welcomed the presbytery.

WORSHIP WITH THE CELEBRATION OF THE LORD'S SUPPER The presbytery entered into worship. Liturgists were ruling elders Wayne Owens, Dean Seger, and Linda Lambert. Teaching elder Rhonda Kruse (Hudson River Presbytery) was the preacher; and teaching elders Karen Larson and Rhonda Kruse co-officiated at the Lord's Supper. Mollie, Linda, and Tim Lambert provided special music, and an offering was received for the Presbyterian Mission Agency. Teaching elder Steven Price-Gibson led in the installation of ruling elder Joyce Dean as moderator, and teaching elder Ivan Dean as vice-moderator. A quorum was declared present. The agenda as amended was approved. Teaching elder Rhonda Kruse, Hudson River Presbytery, was seated as a corresponding member. First time commissioners were introduced. The minutes of the last presbytery meeting were approved as corrected.

Teaching elder Rhonda Kruse, member of Hudson River Presbytery, Mission Engagement Advisor for the Presbyterian Mission Agency, made a presentation concerning the work of the Presbyterian Mission Agency.

COMMITTEE ON MINISTRY Teaching elder Polly Deppen-Williams reported for the Committee on Ministry. They reported the following actions done on behalf of the presbytery: 1) Approved Rev. Bill Harrold (Christian Church, Disciples of Christ) as transitional pastor for Heartland Shared Ministries. He was given authorization to perform the sacraments and to moderate the session. The contract is for January 3, 2017 to January 2, 2018. 2) Approved the Broken Bow and Lexington churches to form pulpit nominating committees. 3) Approved Ivan and Joyce Dean to candidate with the Fairfield and Nelson churches. 4) Approved the terms of call for teaching elder Greg Allen-Pickett as pastor of First Presbyterian church, Hastings, beginning March 12, 2017, and to receive his membership from the Presbytery of Greater Atlanta effective March 12, 2017. a) Effective salary\$80,000 b) Full Board of Pensions Dues c) Social Security offset\$4,080 d) Travel\$2,400 e) Continuing education/professional expenses ..\$3,000 f) Moving expense\$10,000 5) Approved reducing the hours from 40 to 20 per week for commissioned ruling elder Wayne Owens serving the Community Church in Stuart and First Presbyterian Church, Atkinson. 6) Permission was given to commissioned ruling elder Wayne Owens to perform a wedding in Ogallala on August 12, 2017. 7) Teaching elder Bill Nottage-Tacey was approved as moderator for the Fairfield/Nelson congregational meeting and teaching elder Chuck Olsen for the Fullerton congregational meeting. 8) Approved Janene Reynolds to be added to the pulpit supply list. She is not authorized to perform the sacraments. The Committee on Ministry recommended, and presbytery approved, the Plan of Union and Bylaws for the forming of a union congregation with First Presbyterian and First United Methodist, Fullerton, pending the congregational votes on April 30, 2017. The Committee also recommended that the Presbytery council work with the Fullerton Community church regarding per capita.

Teaching elder Greg Allen-Pickett and ruling elder Janene Reynolds were introduced.

COMMITTEE ON PREPARATION FOR MINISTRY Reporting for the Committee on Preparation for Ministry was teaching elder Jill Boyd.

There are four individuals currently under care: Logan Ellis (Inquirer), Zach Spurgeon (Inquirer), David Johnson (Candidate), and Sharon Rees (Candidate). Sharon Rees transitioned from Inquirer to Candidate by the committee on March 14, 2017.

NOMINATING COMMITTEE: No report

PRESBYTERIAN WOMEN Ruling Elder Annabelle Wells reported on behalf of Presbyterian Women of Central Nebraska. Presbytery approved Presbyterian Women be granted permission to celebrate the Lord's Supper at the spring gatherings, at Church of the Plains, Edgar, May 4, 2017, and First Presbyterian North Platte, May 6, 2017. The pastors of the two churches will officiate at the sacrament at their respective churches.

SYNOD SCHOOL Steve and Rose Miller encouraged people to attend Synod School of the Synod of Lakes and Prairies, July 23-28, 2017 at Buena Vista University, Storm Lake, Iowa.

COUNCIL REPORT Teaching elder Steven Price-Gibson reported for the Council. Personnel Committee: The report was presented by teaching elder David Boyd. The new office administrator, Judy Rothenberger, who began work on February 29, 2017, was introduced.

LUNCH: Teaching elder Ivan Dean gave grace and the presbytery recessed for lunch at 11:52 a.m. Presbytery reconvened at 1:00 p.m. The Presbytery entered into a period of prayer led by moderator Joyce Dean. Business-Budget: Ruling elder Steve Miller reported. He announced the process for applying for synod school scholarships. The Committee approved First Presbyterian Church, Grand Island, to borrow up to \$100,000 for organ repair/renovation from other sources than the presbytery. Executive Presbyter Search Committee: Teaching elder Ivan Dean reported that the committee is up and running and on schedule.

YOUTH REPORT Reporting for the committee was teaching elder Dan Davis. Camperships are available for children and youth to attend a camp. Campership applications are available on the presbytery's website. Presbytery adjourned at 1:26 p.m., with ruling elder Joyce Dean closing with prayer.

Committee on Preparation for Ministry
Presbytery of Central Nebraska Meeting

June 24, 2017

Current members of the CPM include Jim Gallentine, Dave Irwin, Karen Woo, and Jill Boyd (chair). Linda Lambert resigned due to a change in her call so we have two vacant positions.

The CPM met on May 4, 2017 to discuss general processes and begin preparing for annual consultations with Logan Ellis (Inquirer), Zach Spurgeon (Inquirer), David Johnson (Candidate), and Sharon Rees (Candidate). Those consultations will be conducted on July 18, 2017.

The committee discussed whether SPM should be completed outside of one's home church. We are strongly encouraging that all candidates do it elsewhere because (1) congregations will always have the tendency to view a child of the church as that instead of as a seminary intern who is there to learn and grow as a leader of the church. This could lead to an affirming experience but perhaps lack in true critical feedback. (2) There is great value in experiencing how other congregations approach worship and other aspects of ministry. Such exposure can provide a broader perspective and understanding of how life in the broader church can be varied.

The committee also discussed the pros and cons of requiring candidates to complete 1 unit of CPE while under the care of this presbytery. (CPE is Clinical Pastoral Education, which typically occurs in a hospital or hospice setting.) It was unanimously agreed that there is great value in both SPM (Supervised Practice of Ministry, which typically occurs in a church or campus ministry setting) and CPE, so the committee would like to require all individuals to complete both before being approved to seek a call. An exception was unanimously approved for David Johnson, who is expected to complete his ordination requirements in the next few months. We believe that in his case, it would be unfair to change the rules for him so close to his completion, though we will emphasize the benefits and encourage him to consider it in the future. With the other three individuals currently under care, they are early enough in the process to incorporate CPE into their plans, and we have conversations with them all that we would be moving toward this recommendation. This will be presented to the Presbytery for a vote at the June meeting.

It is the responsibility of the chair of the CPM to secure readers for ordination exams when it is our presbytery's turn to read. This year is our turn, and the reading periods will take place the weeks of August 7-11 and November 6-10. We need to elect one ruling elder, one teaching elder, and one alternate to read. At the time of this report, not all slots have been filled, but it is my hope to have a complete slate for the presbytery to vote on by the June 24th meeting.

Report of the Presbytery of Central Nebraska Youth Committee
June 24, 2017

The Camp Scholarship season got off to a fast start as usual – within a few weeks of the 2017 campership form getting posted on the presbytery website I had a flood of requests! This is usual as families look to get summer plans in place early. Since then things have slowed down but there is still time to submit camperships for 2017, the deadline is July 19, 2017 so you still have time to encourage kids and families to consider adding a week of camp to the schedule.

So far we have had camperships from five (5) churches for fourteen (14) campers attending five (5) for a total of \$1,782.50!

The churches are: First Presbyterian, Holdrege with 6 campers;
Orleans Presbyterian Church with 2 campers;
First Presbyterian, Axtell with 1 camper;
Westminster United, Minden with 3 campers;
First Presbyterian, Broken Bow with 2 campers.

The camps these kids will be attending are:

Moses Merrill – 1 camper
Camp Timberlake – 7 campers
Calvin Crest – 1 camper
Camp Joy – 3 campers
Kamp Kaleo – 2 campers

Our policy states that campers can apply for funds for half the cost of their camp up to \$200 – this limit was raised 4 years ago as we saw the cost of camps steadily increasing. This year we have had 4 requests for \$200 and 7 requests for over \$115-\$175 and 3 requests for \$22.50-42.50. A majority of churches also reported they also offer camp scholarships as well. That means with the support from our presbytery and from churches summer church camps are still very affordable and always life changing and faith enhancing endeavors!

In other 2017 business we have helped Senior High youth from Grand Island, FPC attend a Christian Youth Leadership conference and we have helped the Grand Island, FPC Director of Faith Formation & Youth Ministry attend the Association of Presbyterian Church Educators annual meeting.
