She introduced the Rev. Denzel Nonhof, Retired, who has transferred from the Presbytery of South Dakota.

Motion made to increase pulpit supply rate to \$100. Motion was approved.

Minium Effective Salary will remain the same for 2025 at \$52,078. The motion was approved.

The Rev. Kirwin Stewart presented the report from the Administrative Commission to close Community Presbyterian Church in Lebanon, Nebraska.

Report of the Administrative Commission to Close the Lebanon Community Presbyterian Church

Report given by Rev. Kirwin Stewart, Chair of the Administrative Commission for Community Presbyterian Church in Lebanon, Nebraska

The administrative Commission made up of Elder Craig Mead, CLP of FPC Beaver City, Elder Virginia Grafton Elder of the Lebanon Presbyterian Church and Rev. Kirwin Stewart MWS FPC Holdrege.

The commission met on October 5th and 26th in order to discuss and decide upon the following issues:

- A. Issue of the transfer of remaining membership of Lebanon
- B. Cost of selling church building and adject lot owned by church.
- C. What shall happen with remaining funds in church bank account
- D. Future dates for a service to be held to close Lebanon Community Presbyterian Church.

It was quickly determined that the remaining 12 members of the Lebanon Community Presbyterian Church, did not wish to close the church. But rather simply with to no longer be Presbyterian.

- 1. The congregation felt that they were no longer able to financial support the larger of the church.
- 2. The congregation had become so small, and the age of its existing members made it difficult to actively participate in the activities of the Presbytery.
- 3. Virginia Grafton explained on behalf of the church that the desire was that she be allowed to buy the building, and once the church was "closed" by the Presbytery of Central Nebraska, they wished to continue as just the community Church of Lebanon, using the remaining funds to continue doing pulpit supply until the money ran out. This would be done without being a formal congregation. That means no boards, Sessions, Elders or other officers.

It was explained at great length the polity of the PCUSA and that the membership would have to be transferred to another affiliated congregation, or the membership could be held with the Presbytery of Central Nebraska.

- 4. Through a series of letters, the remaining members have asked that their membership be held by Central Nebraska Presbytery until such time as each member determines where they would desire to become a permeant member. Those voting to do so were Charlene Springer, Karen Brown, Virgina Grafton, Ronald Grafton, Peggy Grafton, Linda Fitzsimmons, James Fitzsimmons, Steve and LaDonna Harrison and Shawn Bollehon.
- 5. In consultation Rev. Polly Deppen-Williams has suggested the cost of per capita per member (12 members) for 5 years. It is important to cover legal fees. This arrangement would bring the cost of the church to \$2010.00. A counteroffer was presented by Virgina Grafton of \$1000.00. This offer was accepted.

A Congregational meeting was held December 10, 2023, following worship and moderated by Rev. Stewart. There were 8 voting members present. The congregation voted unanimously to the following actions:

1. The Lebanon Community Presbyterian Church officially vote to close the church (at least as far as its connection to the PCUSA)

2. The Lebanon Community Presbyterian Church officially vote to authorize the selling of the building to Virginia Grafton.

Through Rev. Polly Deppen-Williams leadership, she was able to secure a Quit Claim Deed through an attorney in Kearney. The title of the church was then transferred to Virgina Grafton.

With the cooperation of the church's local bank in McCook, Ne. and the Commission, the church treasurer was able to file the paperwork with the IRS to secure a new tax ID number and transfer the remaining account to the new name of The Community church of Lebanon.

Bruce Hendrickson Educational Debt/Scholarship Fund

Purpose:

Bruce Hendrickson gifted money from his estate to the Presbytery of Central Nebraska for scholarships and emergencies. The goal of this fund is to help Ministers of Word and Sacrament in Central Nebraska with debt from undergraduate or seminary education.

Structure:

Up to \$5000 per Minister of Word and Sacrament will be available to help with educational debt from seminary or undergraduate study.

The first category is for new Ministers of Word and Sacrament in the presbytery, the first \$3000 will be paid after three years of service in Central Nebraska Presbytery. The remaining \$2000 will be paid after an additional two years of service in Central Nebraska Presbytery.

For current Ministers of Word and Sacrament in the presbytery, the amount paid will be determined by years of service in Central Nebraska Presbytery.

- 1 year = \$1000
- 2 years = \$2000
- 3 years = \$3000
- 4 years = \$4000
- 5 years = \$5000

The second category is for Ministers of Word and Sacrament wanting to work on an advanced degree can also apply for scholarship under the same guidelines: \$3000 in scholarship funds after three years and an additional \$2000 after five years of service in the presbytery.

Each Minister of Word and Sacrament can apply for only one of the categories of educational debt repayment or advanced degree scholarship at a time.

Payment:

Payment will be made to the loan provider or educational institution in the name of the Minister of Word and Sacrament.

Notes:

- When the money from the fund is depleted, the program will cease to exist.
- Uncommitted funds will also be available to the Council for emergency needs including subsidizing the Emergency Fund of the Commission of Ministry.
