Reports of Council Committees:

Personnel – Ivan reported that his committee is recommending the following salary increases for 2026:

- 2% salary increase for Polly (\$1400.00/year). Council voted to APPROVE.
- \$1.00 per hour increase for Judy (up to 20 hours/week). Council voted to APPROVE.

Business and Budget- Sharon reported the following:

- Committee approved technology grants for repair, replacement, or maintenance of existing equipment up to \$1000. Churches may apply for this money by completing the appropriate application.
- Committee approved the sale of the manse in St. Paul and sale of vacant land in Fullerton.
- Investments continue to grow.
- 2026 proposed budget was reviewed and APPROVED by Council.

Nominating - Council discussed the following:

- A Vice Moderator of Council is needed.
- CPM needs 2-3 new members.
- Council needs 1 At Large member
- Business & Budget has voted to add Greg Allen-Pickett, Judy Rothenberger, Bob Butz (for 3rd term)
- COM requests the approval of Doodle Harris
- General Assembly Commissioners are needed (Ruling Elder, Teaching Elder, Young Adult Advisory)

Reports of Presbytery Committees:

COM – Joyce reported the following:

- Letters recommending Minimum Effective Salary increase of 2% (\$53,120.00) have been mailed to all churches. Council agreed to send recommendation to Presbytery.
- Rev. Dr. Clint Cozier has requested that his membership be transferred to Presbytery of Lake Michigan. Beginning November 1, 2025 he will be serving Three Rivers Presbyterian Church as a Transitional Pastor.

<u>CPM</u> – Jill reported the following:

- Commission has met with Roxanne Whiting-Converse for the final time. They have recommended her to COM for a commissioned call.
- Three additional candidates remain under care including Brian Johnson, Rosalie Koepp and Emily McCreery.

Youth Committee - Eddie reported:

- Several youth from First Presbyterian Church, Lexington attended 2025 Triennium. The event was also attended by a small group of students from Hastings College. Event strengths included small groups and worship times.
- Focus for future will be organizing an annual retreat.

<u>PW</u> – Sue reported that she and Linda Anthony attended a spring event.

Synod – Becky reported that a fall gathering is coming up.

Business and Budget Committee

Presbytery of Central Nebraska Meeting

October 25, 2025

Current members of the Business and Budget Committee include Ann Sukraw-Lutz, Bob Butz, Dan Olson, and Sharon Rees (chair) Ex-officio members include Polly Deppen-Williams, Gary Smith, Logan Ellis, and Becky Dobitsch.

The Committee met on Zoom May 14, July 16, September 3 and 17, 2025.

The Committee awarded three more leadership development grants for continuing education, enlarging the leadership development grant budget because there was greater need than for the technology/mission/church development grants.

The Committee approved a new Technology/Mission/Church Development grant policy for the year 2026. We have discerned a need for some grant funding to replace existing Technology, so an annual amount of \$1000 will be available to churches with such needs. We have also broadened the Mission/Church Development to include support for ministries that otherwise would cease to exist due to lack of funding.

The Presbytery received \$7000 in grant money from the Synod to assist those churches that were hard hit by the increased Board of Pension dues. We matched that funding with \$7000 from the gift given to the Presbytery by the Hendrickson's. This \$14,000 has been distributed to churches that applied for these funds.

To date, we have received no applications for educational debt relief and graduate school scholarship funds, but we expect to receive applications in the future.

The Committee approved monies from the Peacemaking Fund to be distributed to First Presbyterian Church in Hastings for a multi-cultural music camp and to Hastings College for a student mission listening trip in the spring of 2026.

We were saddened to lose our member, Bob Scriven, when he passed to eternal life on August 29, 2025. We also lost Craig Mead due to his move to another Presbytery. We would like to place Judy Rothenberger and Greg Allen-Pickett in nomination for the committee.

The Committee approved the sale of the manse in St. Paul and a plot of land owned by the Fullerton Community Church after due process of approval in those congregations.

The Committee approved the 2026 Presbytery budget pending the suggestions of the Personnel Committee regarding salary and benefits of Presbytery employees. The budget will be presented at the meeting.

Financially, the Presbytery funds are still plentiful and growing. Giving from the churches by the end of August was close to the expected 2/3 mark. The Committee did move more funds to the Reserve Fund so that it equals the annual budget. This is a fund with CD's and money market funds that will be less affected by an economic downturn. Up-to-date financial figures will be provided at the meeting.

The Committee will continue to monitor the monthly financial statements and take appropriate action regarding market trends.

Technology, Mission Development and Church Development Grant Guidelines

These funds are budgeted to provide assistance to the churches within the Presbytery of Central Nebraska. The grants are intended for projects that are beyond the capacity of the annual budget of a congregation. An application is required to apply for this fund. Applications will be submitted to the Business and Budget Committee for final approval.

Technology Grants:

Technology grants that either expand the ministry and/or deliver the Word in ways not presently being done by the applying congregation are eligible for an annual \$2500 grant.

Technology grants that are for the repair, replacement, or maintenance of existing assets are eligible for an annual \$1000 grant.

Mission Development and Church Development Grants:

Mission or church development grants that either expand the ministry, deliver the Word in ways not presently being done, or are required for the maintenance of a ministry that would otherwise cease to exist because of lack of funding are eligible for an annual \$2500 grant.

Synod Representative Report: October 2025

The Synod of Lakes and Prairies held its spring meeting at Mt. Olivet Conference & Retreat Center in Farmington, MN on April 27-29, 2025. Rev. Polly Deppen-Williams, Brian Johnson, and I attended the meeting.

The meeting opened with worship and group building activities. The Synod Staff gave their reports. There were presentations from Kyle Nolan of the Presbyterian Foundation, Ken Green of the Board of Pensions, Erin Anderson of Clearwater Forest, Emily Meyer of Ministry Lab, and Suzanne Kelly, of MN Council of Churches.

On Monday, Rev. Jim Bear Jacobs, Co-Director for Racial Justice of the MN Council of Churches gave a powerful educational presentation focusing on storytelling. He used his personal story as a way to share values and historical truths. His presentation also focused on indigenous land acknowledgements, the doctrine of discovery, the land back movement, reframing relationships and healing and repair. Later in the evening, we gathered in small groups to do our own storytelling and sharing with one another.

Tuesday morning, we heard reports from the Synod's Committees. Highlights included a report from Milessa Carter from the Restorative Action Team. Restorative Actions is a way for white Americans to surrender portions of wealth to Afro-Americans and Indigenous People. The moneys are put into a trust which is then distributed by a Board of Trustees. There are materials and more information available at restorative actions.org.

There was also a report of the Synod sponsored Sankofa Pilgrimage. There were 14 people who went on the trip. They visited Stillman College (Presbyterian HBCU), the Tuskegee Civil Rights Museum as well as other Civil Rights sites in Alabama, Mississippi, and Tennessee.

Financially, the Synod continues be doing well, despite the decrease in Per Capita giving. For every Per Capita dollar that the Synod receives, it gives out \$1.14 in grants and resources. The Synod's investments have done well and more than cover the \$50-80,000 deficit. Due to the continued growth of the investments, the Synod continues to keep the Per Capita at \$5.50.

The Synod is working on developing a YouTube channel to help share information about the Synod in addition to helping churches share their own stories. A Synod Sunday is also being planned. The hope is to make sure that the churches know about the wonderful things that the Synod is doing and become more involved.

There is a great deal of helpful information on the Synod's website for churches, PNCs, Personnel Committees, Session and Deacons training, as well as, the Boundary Training videos.

The Synod of Lakes and Prairies had its fall meeting via Zoom September 28-29, 2025. The meeting began with worship and the celebration of the Lord's Supper. Rev. Bart Roush of Oak Grove Presbyterian Church preached on Matthew 5:1-6. He encouraged us to imagine our world if our guiding principles were the Beatitudes. He reminded us to work from a place of abundance and not from a place of scarcity.

The Steering Committee gave a presentation about Mission, Purpose, Values, and Strategic Focus. As the Synod continues to work on defining itself and charting a course into the future, we looked at each of these four areas and discussed them in small breakout groups. A scripture verse was given for each area to illustrate and focus our discussion.

Our educational presentation was given by Corey Schlosser-Hall which centered on imagining a different or emerging future. He spoke about the importance of story sharing and specifically meaning making through story sharing. Corey explained that story sharing helps give an embodied sense of identity, values, and culture. Corey echoed the encouragement to work from a place of abundance rather than scarcity. As we imagined the future and what it might look like, he challenged us to consider 'what is the capacity of the Holy Spirit?'

We heard the reports from the Synod's committees. The different ways that churches can seek help from the Synod were highlighted—the many resources on the website, scholarships for students, grants through Self-Development of People, scholarships specifically for Nebraska CRE or MDiv students. The proposed budget was passed and the Synod's Per Capita will stay at \$5.50 again for 2026. (It has stayed the same since 2018!) General Assembly will gather in 2026 within the bounds of our Synod, in Milwaukee, WI. Synod will be looking to assist Milwaukee in GA preparations and help during the GA meeting.

The 2026 Synod Meeting dates were announced. The Synod will gather in person at Mt. Olivet on April 26-28, 2026 and then on zoom September 27-28.
